



Christening Photography Contract / Agreement

1. The Parties.

This Christening Photographer Service Contract ("Agreement") made 45th July, 2045 ("Effective Date"), is by and between:

Photographer: Portraits In The Park, with a mailing address of PO Box 728, 2227, City of Gymea, State of New South Wales ("PHOTOGRAPHER", "the Photographer" or "Photography Company")

AND

Client: ClientName, with a mailing address of ClientAddress, City of CityName, State of StateName ("CLIENT")

Photographer and Client are each referred to herein as a "Party" and, collectively, as the "Parties."

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual promises and agreements contained herein, the Client hires the Photographer to work under the terms and conditions hereby agreed upon by the Parties:

2. Scope of Work.

This contract is for services and products related to a Catholic, Macedonian or Greek Orthodox Christening photography shoot (hereafter "shoot" or "the shoot") to take place at the following time and place.

PHOTOGRAPHER to arrive for the SHOOT (Christening) at VenueName (Location/Address) at 02:00 (Start Time) and finish at 01:00 (End Time)

PHOTOGRAPHER agrees to provide the following:

Supply photography service, in accordance with the clients brief (as stated on invoice) and expectations of a professional photographer experienced in capturing Catholic or Orthodox Christenings. With the quality of creative and technical outcome matching the Photographer's portfolio at <https://www.PortraitsInThePark.com.au> as noted; Creative: Composition, Framing, Cropping, Key Moments, General Event Environment, Attendee Interactions with the intention of capturing comprehensive visuals from start to finish. Technical: Aesthetic Exposure, Focus, Colour Balanced, Enhanced Colour Grading, Post-Processing, Naming and Numbering, Delivery by download link.

3. Fees.

In consideration for the photography services provided by PHOTOGRAPHER, CLIENT agrees to pay the sum of \$2,222.⁰⁰ (AUD, Australian Dollars). CLIENT agrees to pay the photographer a non-refundable deposit totaling 20% twenty percent of the total price of the photography services upon signing this contract. The balance of the payment for photography services must be paid in full prior to delivery of photos to client.

3. Work Product.

All photos captured are included in the price for photography services, the following will constitute the entirety of photos to be delivered to CLIENT as high and low resolution digital files and licensed for CLIENTS unrestricted use.

PHOTOGRAPHER will deliver photos to CLIENT no more than fourteen days (14 days) after the date of the SHOOT or final payment, whichever is the latter.
